This address will only be used for the purposes of sending Association circulars and correspondence. It will **not** be used to forward any spam mail or advertising material. The inclusion of email addresses will assist us in communicating all relevant Association news. More than one email address may be included for each boat if any crew members would also like to be on the mailing list.

Also attached to this circular is a **State Championship and Regatta Entry form**. Please note that skippers have two options – they can either place a block entry for the season (which includes the State Championships plus the other interclub Regattas) **OR** enter for individual Regattas that they wish to attend.

Please do not send any money with registration or regatta entry forms as an invoice will be sent to each Club by the Association Treasurer. The only exception to this is Beach Entries at Regattas. That (entry fee) money must be lodged with the entry on the day.
