BUSINESS ARISING FROM PREVIOUS MEETINGS:

Meeting 9th March 2011.

- 1. <u>"Recruiting the next generation" project</u>: We are still awaiting results from the survey. Michael agreed to ask for a timeframe. Mark commented on the need for this feedback so we can determine 'where to from here'.
- 2. <u>St George outstanding payment</u> the Administrator has now paid the outstanding payment of \$910 from the 09/10 season.
- 3. <u>Changes at St George Club</u> There is still no news from the Manly Club in relation to the future status of St George as a legal entity. This is still needed to determine whether the club will be able to have voting rights.
- 4. <u>Australian Association</u> Michael is to speak with the treasurer, Belinda, about sending an invoice to the Australian Association asking them to reimburse NSW Association official's travel expenses from the recent National Titles.
- 5. <u>Sail Measuring</u>: Paul raised a potential issue with the sail measuring document, recently published on the Association website, in particular, that Rule 10 was missing from the Class Rules. Michael said he will investigate this matter.

CORRESPONDENCE IN:

- 1. <u>Illawarra Yacht Club</u> Association received payment for \$1,690 (received on 28th January 2011).

AUSTRALIAN ASSOCIATION

- 1. Lloyd has spoken with Rob Wasson of the Australian Association and has been notified that entry fees for the Australian Titles will rise, effective from next season (2011/12). The amount has yet to be quantified.
- 2. Rob Wasson was contacted about the upcoming event at Hervey Bay, seeking feedback as to what NSW will need to supply in terms of race officials. It was noted that the Australian Association will need to cover the expenses of those required to attend.
- 3. The Australian Executive conducted a meeting via Skype last Monday.

13FT SKIFF REPORT

- 1. <u>Middle Harbour</u> Ed Darmanin reported that Middle Harbour will be running a mixed fleet including 29ers on Sundays next season and the usual 13ft skiffs on Saturdays.
- 2. <u>Manly</u> Ed also reported that Manly are trying to separate the administration of the 13's and 16's to give some autonomy to the 13ft skiffs, primarily to encourage involvement of volunteers to take over some management issues of the Class. They wish to have representatives of the 13ft skiff community on their own committee rather than relying totally upon direction from the 16s committee.

GENERAL BUSINESS:

1. <u>Flying Ants</u> - Paul Linnett reported that he had been approached by Peter Little of the 'Flying Ants' Association wanting to hold events at the same time (weekends) and location as each of the 16ft Skiff State Title events next season. This would involve about 20 Flying Ants.

A number of concerns were raised, such as whether the Flying Ants would start after the 16s or whether they would need to race before hand and be off the water when the 13s and 16s are racing. That would then create an issue if the weather were either very light or heavy such that race starts would need to be delayed. There would also be logistical issues around parking and rigging area space at some locations.

Ed felt the Flying Ant Association would need to liaise with host clubs to take an active role in the running of the events, as our Association does not have the resources to do this task.

Mark Graham felt we could give the Flying Ants an in principle 'yes' to their request but we would still need to consider the logistical issues raised.

Roger pointed out that some clubs had not responded well to 13ft skiffs sailing at 16ft skiff regattas. He suggested that feedback from clubs should be sought before making a final decision. This was agreed to.

There was also discussion about promoting the progression at Illawarra from Flying Ants to 13ft Skiffs to 16ft Skiffs and that this was partly behind the suggestion concerning the State Championships.

2. <u>New Boatshed at Belmont</u> - Lloyd informed the meeting that construction of the new boat shed at Belmont would begin on the Wednesday after Easter. It is expected to be completed in September of this year.
